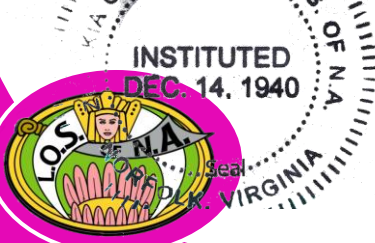

Message from the Junior Past High Priestess

They didn't have to work for it, they didn't have to sell anything for it, they just had to show up! Masonic Youth are the future of the adult Masonic organizations. We need to plant the seeds and nurture them as they are the future Lady Shriners, Masons, Shriners and Eastern Star members. We need to celebrate and encourage them! 15 Zulekia ladies are attending Bethel #42's Murder Mystery Theater on April 5! The comment was made to Lady Cheryl, HP when she and Noble Wayne were at Philly hospital that no one had ever done this before for the youth, hosting a party just for fun for them.

Building Operations | Building Rentals

It has been a productive few months and as we finish out the year with our High Priestess, Lynn Hollandsworth and her dedicated service, we continue to improve on the building and focus on maintaining the facility in an orderly and timely manner. I am confident that High Priestess Cheryl Valeriano will lead our court and our building in the right direction.

I would like to take a moment to thank the ladies of the court who make up the building committee and continue to make time for the monthly meetings. The committee is always looking for more volunteers, and right now we are in desperate need of a secretary. We meet monthly on the last Thursday of the month at 7:00PM. The meetings typically last about an hour. Please consider helping. The next meeting is April 24, 2025, at 7:00PM.

All the building's annual inspections have been completed. This covers the fire sprinkler systems, fire extinguishers, alarm system, kitchen hood system and backflow system. The fire Marshall stopped by and did his inspection, and we have been issued an occupancy certificate for another year. The grease traps have been cleaned out, all the kitchen appliances have been inspected and serviced, plus, all three HVAC units have been inspected and serviced. A new security camera and monitor have been installed, and it has added an extra layer of security in the building. The floors have been cleaned as well as striped and waxed, the parking lot got a lot brighter once we had 5 trees removed! More work needs to be done in the parking lot to prevent tripping hazards. This will be addressed in the coming months.

How wonderful it is that our building rentals have kept our calendar full. These events help keep the building funded for future necessities and it is very important that we have volunteers to fill the shifts. Lady Lynn H. PHP has graciously accepted the role of building event manager. She will be reaching out asking for help. Please, when called upon to help, step forward.
